Earning Provisions: Jolica Gift Consultants will receive commissions on personal sales and bonuses on their team sales as long as they maintain an active status. In order to become a Jolica Gift Consultant, individuals must purchase a Starter Kit.

By signing this agreement, both the Company and Gift Consultant acknowledge and agree to all of the terms contained herein and shall be bound by all such terms.

The Gift Consultant acknowledges that she/he is at least 18 years of age or older. The Gift Consultant is an independent, self-employed person, not an employee, agent, franchisee, partner or legal representative of the company and is not covered by Unemployment or Worker's Compensation legislations. The Gift Consultant shall be solely responsible for any and all provincial and federal taxes due and payable on earnings, prizes, or awards received from the Company. The consultant shall have no power or authority to bind the Company or to assume or create any obligations or responsibility, expressed or implied, on the company's behalf, or in its name, nor shall she/he represent to anyone that she/he has such power or authority, except as expressly provided for in this Agreement.

The Gift Consultant shall promote, demonstrate, and/or display the company's products as the consultant deems most effective, but shall always do so in a truthful and honest manner so as to protect the reputation of the company. The Gift Consultant agrees to follow all policies and procedures established by the company, including but not limited to, all those contained in the Consultant Manual, as it may be amended and revised from time to time and posted to the website.

The Gift Consultant is only authorized to sell the Company's products through direct sales methods. For internet sales, the Gift Consultant is only authorized to offer for sale and to sell the company's products through the Company provided Gift Consultant website. The Gift Consultant agrees that she/he shall not market, represent, promote, offer for sale, or sell the company's products, programs, or opportunities in conjunction with any other products and/or services, including but not limited to, at any home party, trade show, fair or festival, where the Gift Consultant is also marketing, representing, promoting, offering for sale, or selling the products, services, programs, or opportunities of any other retail or direct sales company.



When acting as a Hiring Gift Consultant, the consultant shall always present and represent the company's opportunities in an honest and truthful manner. The Gift Consultant agrees that any new gift consultant that she/he may sponsor shall be at least 18 years of age or older.

The Gift Consultant shall be paid earnings equal to 27% of the Consultant's Paid Regular Priced Product Sales submitted on Parties ("Paid Product Sales"). The Gift Consultant's 27% earnings shall include Home Parties and Catalog / Web Site Paid Product Sales. The Gift Consultant can also qualify for bonuses on the Paid Product Sales of her/his team according to the terms set out in the Consultant Manual. Earnings are subject to the "Earnings Provisions" set out above.

Gift Consultant earnings, less any deductions for amounts owing by the Gift Consultant to the Company, shall be paid to the Gift Consultant every month (amounts under \$10.00 will be carried forward). Full details concerning earnings are contained in the Gift Consultant Manual.

The Company will calculate and pay earnings to the Gift Consultant in accordance with the above terms but may change the percentage, amount, and payment of earnings at any time provided that it gives 30 days prior written notice to the Gift Consultant.

The Company is at all times authorized to use, in any manner it deems appropriate, any and all information respecting customers, including, but not limited to, names, addresses and phone numbers, and reserves the right to continue to service and provide products and services to customers if the Gift Consultant ceases to be a Gift Consultant for the Company and/or violates any terms of this Agreement or the Company's Manual or other Company policies and procedures.

The Gift Consultant agrees that the Company may release her/his name, email address, and telephone number to a customer or prospective customer unless the Gift Consultant has notified the Company in writing that she/he does not want such information released.

The Gift Consultant acknowledges and understands that information and materials provided to her/him are confidential and constitute proprietary information owned by the Company and that she/he shall not disclose, reproduce, or use any of this information or materials for any other purpose than his/his business as a Gift Consultant for the Company.

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario. Both the Company and the Gift Consultant agree that the Courts of the Province of Ontario shall have jurisdiction to entertain any action or other legal proceedings based on any provisions of this Agreement.

This Agreement may be terminated by either the Company or the Gift Consultant by providing written notice of the intention to terminate. This Agreement shall not be binding until signed and accepted by an authorized representative of the Company. A signed copy of this Agreement will be sent to the Gift Consultant.
